We have been notified by the Board of Equalization that all crafters must have a resale license. Go to [www.boe.ca.gov](http://www.boe.ca.gov) to get your permit (it is free) and send a copy of your permit with this application. Each space is approximately 10' x 10'. The fee of \$35 per space is non-refundable. The Park will open at 6:00 a.m. for set-up. It will be open to the public at 9 a.m. and close at 4 p.m. We are asking you to off-load your crafts and equipment and then immediately move your vehicle(s) off-site to allow others the same courtesy. Remember, the farther away you can park, the closer your clientele can. Coffee and donuts will be available at 7:00 a.m. at the Lott Kitchen. Lunch and drink items will also be available throughout the day.
